Micro-Loan Information

- ◆ Harvey County funds can be partnered with funds from other loan programs.
- ◆ Owner and/or employees must be considered in the Low to Moderate Income Level.
- ◆ The business may be located anywhere in Harvey County.
- ◆ May be used as a loan guarantee to a local lending facility.

“What could I do with a Micro-Loan?”

Here is what others have done...

- ◆ Jim had a thriving business mowing lawns during the summer months. He applied for a Micro-Loan and used the money to purchase winter equipment, including snow removal equipment, so he could operate his business year-round.
- ◆ Rita always dreamed of opening her own deli, but needed kitchen space and equipment of her own. After receiving a Micro-Loan, she was able to rent kitchen space and buy the right equipment, fulfilling her dream of opening a deli-style shop.
- ◆ Lisa knew that affordable daycare was needed in her community, but didn't have room at her home and needed money to open and operate a daycare program. A Micro-Loan helped buy space for a daycare center and purchase materials for activities. Now, Lisa is thinking about expanding again!
