In two short years our project leads have doubled.

This lead growth creates exponential opportunities for new jobs, new businesses, and overall economic growth in Harvey County. And significant increases in economic development project lead development do not happen overnight – it has been through intentional focus and dedicated efforts from the EDC Board of Directors, our staff, and partners at the local, regional, and state levels.

I am proud to announce that we are seeing results of our strategic and collective efforts. In the last year, we won \$12.3M in capital investment and 164 new jobs.

In addition to business attraction efforts, we are dedicated to supporting our local companies; they are paramount to the health and vibrancy of Harvey County. Through our business retention program, we completed over 60 intentional business visits this year. This program builds trust within our local business community and promotes that the EDC and community support our current employers.

As we head into 2023, economic development efforts will continue to be critical for the continued growth and vibrancy of our community. Working alongside staff and the Harvey Co. EDC Board of Directors, I look forward to:

- Exploring every lead and job growth opportunity for Harvey County, especially within our industrial parks
